Circular

Dear colleagues,

The European North is a vast region with distinct climatic, geographical and social features, unique ecosystems, historical, cultural and resource potential. Over the years, countries and regions in the European North have been working systematically to build the system of protected areas (PAs) based on existing interregional and international arrangements. The scaffold of this system is green belts (meridians) which link PAs to form one system.

One of the pivotal events in the process of building the North European PA system was the signing on February 17, 2010 of the Memorandum of Understanding on Cooperation for the Development of the Green Belt of Fennoscandia (GBF) between the Ministry of Environment of Norway, the Ministry of Environment of the Republic of Finland and the Ministry of Natural Resources and Environment of the Russian Federation. This document rendered a new impetus to the development of GBF per se and conservation work in general, which has been evidenced, among other things, by an increased number of international projects.

Considering the high interest that science, authorities, business and non-profit organizations have demonstrated for PA network development in the European North, it has been decided to organize the international conference "International and interregional connectivity of protected areas in the European North" within the framework of the National Year of Protected Areas, Nature Protection and Environment at the Karelian Research Centre RAS (Petrozavodsk) in November 2017.

The aim of the conference is to urge the participants to discuss the possibilities for developing the North European PA system not focusing on the conservation of unique ecosystems (biodiversity) alone but also considering the role of PAs in the sustainable development of northern regions and addressing their socio-economic problems. The conference will particularly discuss the possibilities of developing ecological innovations and ecosystem services based on the use of latest technology and more efficient utilization of the scientific and research potential of North European regions.

The provisional central themes for the conference are:

- Natural complexes of North European PAs (characteristics and protection specifics)
- Development of the PA network and establishment of the North European ecological framework based thereon
- PAs and the strategy of sustainable socio-economic development of the European North
- Ecosystem services in PAs and 'green economy' concept for the region
- Historical and cultural heritage of North European nationalities
- Environmental education and awareness, eco-tourism in PAs of the region

This listing of themes is not exhaustive: additional sessions and roundtables can be arranged following participants' suggestions.

The conference will have plenary talks – 20 min; presentations at thematic sessions – 15 min plus discussion (5 min) and poster presentations.

Use the first speaker's surname in Latin symbols as the file name (e.g. ivanov.rtf). Abstracts are to be submitted in English. Russian-speaking applicants are required to submit their abstracts in both Russian and English. Avoid including tables, figures and list of references in the abstract. Italicize Latin names of species.
